- 1. Impact on availability of specialized doctor services : As corporate sector is involved in affording medical treatment good doctors are hired by these companies. Hence government hospitals & clinics are suffering from lack of specialized doctor services.
- 2. Increased privatization- Health care sector is privatized & is largely at the mercy of private sector funding. This is a great threat to the industry as private sector medical companies are demanding more tax concessions, land, water & other infrastructure & the profit so earned is not invested in India but it is taken outside India . Hence India is deprived of its seed capital returns.

India is a still suffering from mal nutrition & under nourishment. Children aged 0-5 years are suffering form diarrhea , mal nutrition etc & India is reinventing medical tourism with surrogate motherhood which is a ridiculous. Indian children are dying for lack of food & facility & foreign women are welcomed here for conceiving with new technology. India has to look towards strengthening basic medical support system & then channelize on foreign tourists. 3. Impact of regional medical challenges As global health indicators indicate



while Indians suffering from acid attacks, burns injuries are left to die as the medical treatments are sky rocketing &beyond their expenditure limit.

- 5. Increased privatization pre-judicial treatment: Indian health sector is plagued by biased treatment priorities. Private hospitals charge exorbitantly for poor Indians .Most of these hospitals do not even give entry to weaker sections. Poor people who sale off their entire properties to get good medical treatment, lose their life , yet do not receive good timely treatment for their ailments. One of the major reasons for poverty in rural areas has been the insufficient medical aid.
- 6. Increased corporate priorities: Corporate hospitals reserve specified number of beds for poor & weaker sections but this does not address the problem. Indian tax payer's money is being utilized for building these sky raise hospitals but these hospitals deny treatment to Indian citizens. The corporate run hospitals enjoy heavy subsidies, tax benefits, free landscapes at through away prices.

mpact of delay in government interventions : Government interventions are needed to rectify these anomalies. The government should stop giving red carpet welcome to corporate health companies. 9 National health policy 2015 Ministry of Health & family welfare , Government of India , New Delhi 2015).


