

Stock Market Volatility And The Application Of Volatility Trading Models - Using By 'R' Application

Abstract

In this paper, we have examined the effects of price limits on the stock volatility in the Indian Stock Exchange. Results indicate the dominance of TVS company price volatility on real stock returns and emphasize how this has increased over time. This paper examines behavior of stock return volatility in the Indian stock exchange market phases for the TVS Motors share index. A price series or an economic indicator that changes a lot and swings wildly is said to be "volatile". The research covers a sample of one company i.e. TVS Motors share price movements using monthly data from 31^{st} March, 2015 to 31^{st} March, 2016. The study found that there is an increasing in both trading volume and stock price volatility, which may be considered as a recent phenomenon in the majority of the Indian stock market. This is difficult, if not impossible, because we cannot say that volatility is necessarily stochastic or that it conforms to any mathematical model; all we know is that the evolution of volatility is uncertain. An accurate estimate of volatility is, however, crucial in many applications, including risk measurement and management as well as option pricing and hedging. We expand the application 'R' model by examining the dynamics of out of sample causality through the variance decomposition and impulse response function techniques.

Introduction: Stock prices change every day as a result of market forces. By this we mean that share prices change because of supply and demand. If more people want to buy a stock (demand) than sell it (supply), then the price moves up. Conversely, if more people wanted to sell a stock than buy it, there would be greater supply than demand, and the price would fall. Understanding supply and demand is easy. What is difficult to comprehend is what makes people like a particular stock and dislike another stock. This comes down to figuring out what news is positive for a company and what news is negative. There are many answers to this problem and just about any investor you ask has their own ideas and strategies.

The most important factor that affects the value of a company is its earnings. Earnings are the profit a company makes,



and in the long run no company can survive without them. It makes sense when you think about it. If a company never makes money, it isn't going to stay in business. Public companies are required to report their earnings four times a year (once each quarter). Wall Street watches with rabid attention at these times, which are referred to as earnings seasons. The reason behind this is that analysts base their future value of a company on their earnings projection. If a company's results surprise (are better than expected), the price jumps up. If a company's results disappoint (are worse than expected), then the price will fall.

Volatility: In finance, **volatility** is the degree of variation of a trading price series over time as measured by the standard deviation of returns. Historic volatility is derived from time series of past market prices. An implied volatility is derived from the market price of a market traded derivative (in particular an option). The symbol σ is used for volatility, and corresponds to standard deviation, which should not be confused with the similarly named variance, which is instead the square, σ^2 .

Volatility for investors: Investors care about volatility for seven reasons:

The wider the swings in an investment's price, the harder emotionally it is to not worry;

Price volatility of a trading instrument can define position sizing in a portfolio;

When certain cash flows from selling a security are needed at a specific future date, higher volatility means a greater chance of a shortfall;

Higher volatility of returns while saving for retirement results in a wider

distribution of possible final portfolio values;

Higher volatility of return when retired gives withdrawals a larger permanent impact on the portfolio's value;

Price volatility presents opportunities to buy assets cheaply and sell when overpriced;

Volatility affects pricing of options, being a parameter of the Black–Scholes model.

In today's markets, it is also possible to trade volatility directly, through the use of derivative securities such as options and variance swaps. See Volatility arbitrage.

Volatility versus direction: Volatility does not measure the direction of price changes, merely their dispersion. This is because when calculating standard deviation (or variance), all differences are squared, so that negative and positive differences are combined into one quantity. Two instruments with different volatilities may have the same expected return, but the instrument with higher volatility will have larger swings in values over a given period of time.

Volatility over time: Although the Black Scholes equation assumes predictable constant volatility, this is not observed in real markets, and amongst the models are Emanuel Derman and Iraj Kani's and Bruno Dupire's Local Volatility, Poisson Process where volatility jumps to new levels with a predictable frequency, and the increasingly popular Heston model of stochastic volatility. It is common knowledge that types of assets experience periods of high and low volatility. That is, during some periods, prices go up and down quickly, while during other times they barely move at all.

Company Profile: TVS Motor Company is the third largest two-wheeler manufacturer in India, with a revenue of Rs.10,131 Cr (\$1.5 billion) in 2014-15. It is the flagship company of the Rs. 40,000 Cr (\$6 billion, in 2014-15) TVS Group. The company has an annual sales of 2.5 million units and an annual capacity of over 3 million vehicles. TVS Motor Company is also the 2nd largest exporter in India with exports to over 60 Countries. TVS Motor Company Ltd (TVS Motor), member of the TVS Group, is the largest company of the group in terms of size and turnover, with more than 2.8 crore customers riding a TVS bike.

Conceptual Theories (Application of 'R'): Though the term statistical learning is fairly new, many of the concepts that underlie the field were developed long ago. At the beginning of the nineteenth century, Legendre and Gauss published papers on the method of least squares, which implemented the earliest form of what is now known as linear regression. The approach was first successfully applied to problems in astronomy. Linear regression is used for predicting values, quantitative such as an individual's salary. In order to predict qualitative values, such as whether a patient survives or dies, or whether the stock market increases or decreases, Fisher proposed linear discriminant analysis in 1936. In the 1940s, various authors put forth an alternative approach, logistic regression. In the early 1970s, Nelder and Wedderburn coined the term generalized linear models for an entire class of statistical learning methods that include both linear and logistic regression as special cases. By the end of the 1970s, many more techniques for learning from data were available. However, they were almost exclusively



linear methods, because fitting non-linear relationships was computationally infeasible at the time. By the 1980s, computing technology had finally improved sufficiently that non-linear methods were no longer computationally prohibitive.

What is Statistical Learning: In order to motivate our study of statistical learning, we begin with a simple example. Suppose that we are statistical consultants hired by a client to provide advice on how to improve sales of a particular product. The Advertising data set consists of the sales of that product in 200 different markets, along with advertising budgets for the product in each of those markets for three different media: TV, radio, and newspaper. It is not possible for our client to directly increase sales of the product. On the other hand, they can control the advertising expenditure in each of the three media. Therefore, if we

determine that there is an association between advertising and sales, then we can instruct our client to adjust advertising budgets, thereby indirectly increasing sales. In other words, our goal is to develop an accurate model that can be used to predict sales on the basis of the three media budgets.





























The correlation for returns of TVS motors and Ashok Leyland 0.43.


Autocorrelation: An autocorrelation plot shows the properties of a type of data known as a time series. A time series refers to observations of a single variable over a specified time horizon. For example, the daily price of Microsoft stock during the year 2013 is a time series. Cross-sectional data refers to observations on many variables at a single point in time. For example, the closing prices of the 30 stocks contained in the Dow Jones Industrial Average on January 31, 2014, would be considered cross-sectional data. An autocorrelation plot is designed to show whether the

elements of a time series are positively negatively correlated, correlated, or each (The independent of other. prefix auto means "self" autocorrelation specifically refers to correlation among the elements of a time series.) An autocorrelation plot shows the value of the autocorrelation function (acf) on the vertical axis. It can range from -1 to 1. The horizontal axis of an autocorrelation plot shows the size of the between the elements of the time series.

Autocorrelation, also known as serial correlation or cross-autocorrelation, is the cross-correlation of a signal with itself at different points in time (that is what the cross stands for). Informally, it is the similarity between observations as a function of the time lag between them. It is a mathematical tool for finding repeating patterns, such as the presence of a periodic signal obscured by noise, or the missing identifying fundamental frequency in a signal implied by its harmonic frequencies.



The Autocorrelation plot below shows that the time series is random, but rather has a low degree of Autocorrelation between adjacent and near-adjacent Chart No: 4.5.2a observations. Plot is drawn from the RETURNS of TVS motors and ASHOK LAYLAND motors.




Interpretation

Autocorrelation exists when the lagged line touches or crosses the blue dotted line.

There is no perfect autocorrelation in all the remaining lags expect the 4th lag.

Lagged Correlations: Lagged relationships are characteristic of many natural physical systems. Lagged correlation refers to the correlations between two-time series shifted in time relative to one another. Lagged correlation is important in studying the relationship between time series for two reasons. First one series may have a delayed response to the other series, or perhaps a delayed response to a common stimulus that affects both series. Second, the response of one series to the other series or an outside stimulus may be "smeared" in time, such that a stimulus restricted to one observations elicits a response at multiple observations.



Interpretation
